### **OVERVIEW**

**Farm Summary:** This farm was a productive farm 3 decades ago. With challenges to make ends meet as a Farmer, the original owner put this farm in CRP and CREP to preserve the water rights and collect Government payments. Recently, PEP (Seller) has brought this farm back online with a new and improved irrigation system and would like a lease back.

Irrigation System: The farm includes (2) Zimmatic pivots installed in 2022, 20 ¼ mile thunderbird wheel lines with new hubs and refurbished transmissions, 4 corners of smaller wheel lines, new PVC mainline as of 2022, and 2 irrigation wells <u>(static water at</u> <u>125')</u> with refurbished motors/pumps and new electric panels. **Soils:** With virgin dirt to grow potatoes and sugar beets, these soils consist of a silt loam variety with approximately 6% classified as Class II, 80% Class III, and the remaining 14% being Class IV+. (see Soil Map on pg 3)


